

HPCA Meeting Minutes April 1, 2025

1. Meeting started at 7:01p.m.
2. Agenda Approval; One addition to "Other Business"; Move to Approve by Linda. No Objections. Approved.
3. Councillor's Office Report
 - a) **Update on Community Building:** Payment order is out for the Community Building. Will report back on the timeline at the next meeting.
 - b) **Tax Ratio Report:** The City is reducing the multi-residential tax ratio to mirror that of residential rates. The goal/expectation is that landlords pass the saving onto tenants.
 - c) **Ottawa Tool Library:** There is a small appliance *Repair Café* planned (Date to be determined) at the RA Centre. Catlin asked what languages, in addition to French and English, should the publicity include. Suggestion: Arabic
 - d) **Presentation by Connor R. on the Rain Ready Ottawa Program:** Rain Ready Ottawa is a program that encourages and supports residents to reduce the harmful impacts of rainwater runoff on their property.

- Information on projects for your home (see below) including a series of self-guided eLearning courses to help you implement rainwater management projects

Some questions for Connor: Do rebates included soft landscaping – Yes. What reimbursable costs are covered for a "Rain Garden" – costs calculated on area basis – 10 meters sq, up to \$750. Does the City have a list of salt-tolerant plants? Yes – will share.

4. 2025 Cleaning the Capital

Linda G-P informed the Association that she had submitted Stewardship Agreement for the Orchard and the Green Space around it to the City. The Agreement is to allow Volunteers to continue removing the invasive plants and planting native trees and shrubs as they have been doing for the past few years. The Association is formalizing this arrangement with the City. We do not receive any funding for this voluntary work.

There was a request that we post on the website a date for volunteers to come and help with the Orchard and the Green Space maintenance.
